

All major site plans and major subdivision preliminary plats shall be submitted 45 days in advance of the Planning Board meeting at which they are to be reviewed.

Subdivisions must meet the requirements of Article 10, Part VI of the Unified Development ordinance, as well as any other applicable development regulations. The minimum information to be depicted on a plat is included at the end of this application. The review process is outlined in Section 5.4 and 5.7 of the Unified Development Ordinance.
